1. CHARITY GUILD SHOP ACCEPTS MERCHANDISE UNDER THE FOLLOWING CONDITIONS:

- A. APPAREL - Laundered/dry cleaned, pressed, in good condition, on hangers, in current style and season. Children's garments are sizes 0-12. ACCESSORIES - Shoes, purses, belts, scarves, ties and hats must be in pristine condition. JEWELRY - No broken pieces or missing stones.
B. HOUSEHOLD - Clean, in good condition and working order.
C. FURNITURE - By appointment only - Request an appointment by emailing furniture@charityguildshop.org (preferred) or call the shop, 713-529-0995.

Consignors may consign monthly in Apparel Receiving, weekly in Household Receiving.

NO CONSIGNMENT IS ACCEPTED WITHOUT AN ITEMIZED LIST FOR EACH CATEGORY.

- 2. In order to be accepted for consignment, items must be salable for a minimum of \$10.00 for adult apparel and \$10.00 for household items.
3. Charity Guild Shop retains the right to determine pricing for every item consigned, but consignors are welcome to suggest prices.
4. Charity Guild Shop is not responsible for loss or damage for any reason.
5. Most items are marked down 25% on the 30th day from the original price date and 50% on the 45th day from the original price date. On the 60th day from the original price date, any item not sold becomes property of Charity Guild Shop.
6. The consignor agrees consigned items which cannot be priced by Charity Guild Shop or have not sold by the 60th day from the date priced, automatically and with no notice to the consignor, become the property of Charity Guild Shop. The consignor has no further claim to such items.
7. Charity Guild Shop pays consignors 60% of the selling price if sold before the 60th day. The 40% retained by Charity Guild Shop is a consignment fee. Therefore, it is not tax deductible as a donation.
8. Consignor checks for merchandise sold are mailed no later than the 15th of the following month for accounts with a balance of \$15.00 or more. In November, checks are issued for accounts with a balance of \$4.00 or more. In May, checks are issued for the account balance. A fee of \$10 is charged to reissue a check.
